


Unemployment Rate (Seasonally Adjusted, Monthly)







100% Integration:

Ensure that 100% of investment decisions on corporate securities are analyzed through ESG factors

Comprehensive Approach:

Maintain a minimum ESG portfolio rating of investment grade or higher

Commitment to UNPRI:

Become a signatory to the United Nationssupported Principles for Responsible Investment

Commitment to Carbon-Neutrality:

Achieve a carbonneutral portfolio from an investment perspective by 2020

Why ESG/Sustainable Investing?



- **Sustainability** is a decision-making perspective that takes into account a broad array of stakeholders and systems, present and future. Sustainable decisions aim not only to meet present needs, but to strengthen social, environmental, and economic systems, while preserving the ability of future generations to make decisions that meet their own needs.
- Sustainable investing incorporates ESG considerations into the investment process with the recognition that the broader context within which an investment exists can affect its risk and return, and that investments themselves can have broader social, environmental, and economic impacts beyond their financial return.





ESG in Fixed-Income Investing: Key Findings



- **Performance**: High ESG → Better Performance (Barclays 2016)
 - High-ESG portfolio outperformed Low-ESG portfolio by cumulative 2% over seven years
- Credit Risk: Low ESG → Wider CDS Spreads (Hermes 2017)
 - Low-ESG-rated companies in four CDS indices had wider spreads than the High-ESG-rated companies in the indices

Funds that have been around for a decade perform on par with peers


